Introduction

These release notes are compiled to provide information about enhancements and features.

Note: The release notes are incremental and therefore only cover the changes and enhancements that have been programmed since the 8.35.9304 release.

System Requirements

Connection Manager, offering greater reliability and functionality over telnet, is the only recommended connection method for systems running KCML6.

Available memory should be 10 MB per user.

Windows 2000 and Windows XP are the recommended operating systems for PCs that run Kclient. Earlier Windows products unsupported by Microsoft are no longer endorsed as recommended platforms for KClient.

For optimal screen displays, we suggest screen resolution be set to 1024 x 768 on hardware that will support this.

- **KClient version used for KCC 9304A testing** - version 06.20.08.10168 - or newer
- **KCML upgrade used for KCC 9304A testing** - version 06.20.08.10168 - or newer
- Licence upgrade to include an Autoline Unrestricted licence
- To use **KCBT**, a KCBT viewer is required on all client PCs concerned.
- KClient setup file and KCML IMAGE files for all operating systems can be found on <http://www.kcml.com/kcml/06.20/>

Note: For systems using a non-standard back-up method that creates a token file in /tmp on completion of the back-up, administrators will need to be aware that the system now uses \$WORKSPACE instead of /tmp. Please refer to your Technical Consultant to ensure that changes have been made to accommodate this.

NL report writer	-	1786 - E8 - In the NL report writer, one can include/exclude some logic based on the value of a register. (register in this case being a command that performs certain functions). This enhancement allows such logic to be included for the Trial Balance formatting language. It allows the conditioning of something happening [i.e execution of a command] based on a register value.

-	-	 1857 - E8 - A new button has been added to the resource record in workshop loading called 'Picture'. The picture button opens the upload picture form to allow the user to transfer the technician's picture from their PC to the WL pictures gallery on the server.

-	-	1726 - R8 - Re-introduction of field validation on user defined forms.

-	-	1777 - E8 - New messages within the vehicle casefile: "Mileage exceeds Manufacturer's warranty maximum mileage" or "Mileage inside Manufacturer's warranty maximum mileage", displayed when the maximum mileage has been populated. also displays the last service or the last work miles.
-	-	 33385 - R8 - Franchise data companies within MK vehicle record maintenance must comply with both standard permissions & security and company mapping.
